



## NET CREDIT UNION OFFICIAL SWEEPSTAKES RULES

- 1) No purchase or obligation necessary to enter or win. Non-purchase entries and purchase entries have an equal chance of winning.
- 2) **Eligibility:** The NET Credit Union Sweepstakes is open to legal residents of the United States and to those who are 18 years of age or older as of 03/01/2006. Business Account Members are not eligible. Entrants must be NET Credit Union auto loan account holders whose accounts are in good standing. Employees and volunteers of NET Credit Union are not eligible to enter or win. Void where prohibited. Refinanced auto loans do not include current NET auto loans.
- 3) All accounts must meet NET Credit Union membership eligibility requirements. A \$5 Membership Fee is required to open a new account.
- 4) **Sweepstakes Timing/Description:** Begins at 12:00 AM Eastern Time on 03/01/2024 and ends at 11:59 PM Eastern Time on 04/30/2024

A random drawing will be conducted by NET's Marketing Department and their decisions for qualification are final and binding. The potential winner will be notified via telephone or email within five (5) business days of the random drawing date.
